It is also made clear that, the candidature of these candidates for this recruitment is purely provisional and subject to fulfillment of terms and conditions laid down in the advertisement. The candidature is liable to rejection in the event of inadequacy/deficiency found at any stage before or after the V.V. Test.

The Intimation Letter of the candidates concerned and "Attestation Form" & "Bio Data Form" is available in the Website. The candidates are required to download their "Intimation Letter", "Attestation Form" & "Bio Data Form" from the website of the Commission at <http://opsc.gov.in> and produce the same for admission to V.V. Test.

The candidates are also required to bring all the Original Documents for verification on the day of V.V. Test.

List of Original Documents to be furnished in the following order

1. Attestation Form duly filled in (To be downloaded from the website of the Commission).
2. H.S.C. or Equivalent Certificate in support of Declaration of Age.
3. Intermediate/+2 Examination Certificate.
4. Bachelor's Degree Certificate issued by the recognized University.
5. Bachelors Degree in Law Certificate issued by the recognized University.
6. Mark-sheets in support of all the aforesaid Examination (i.e. H.S.C. to LLB Degree) passed including fail marks, if any issued by the concerned Board/Council/University.
7. Certificate of Enrolment to Bar Council.
8. Certificate from the District Judge in support of prescribed 3 (years) years of experience at the Bar as practicing Advocate in the prescribed format vide **Appendix-B**.
9. Certificate from the competent authority in support of 12 years of service experience in any Group-C post in any Department of Government, other than the employees of Common cadre.
10. Required Odia Pass Certificate.
11. Aadhaar Card in original and it's photocopy duly attested by the candidate.
12. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).
13. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by birth issued by the Competent Authority (issued within 3 years), wherever applicable (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.

14. In case of Sports Person candidates: Identity card issued by Director of Sports, Odisha.
15. In case of PWD candidates: Disability Certificate (Indicating % of disability) issued by concerned Medical Board, wherever applicable.
16. In case of Ex-Servicemen candidates : Discharge Certificate issued by the Commanding Officer of the Unit Last served/Identity Card issued by Rajya Sainik Board or Zilla Sainik Board in original.
17. The Ex-Servicemen candidates are required to furnish an Affidavit in original indicating that-

“I have not got any appointment as an Ex-Serviceman against Civil Post against the Quota available for the said category”.

OR

Certificate in Original issued by the Employer/Controlling Authority showing the Date of Joining in the Civil Post/Service in the Government Job on the civil side availing the Ex-Servicemen benefit.

OR

An Affidavit in Original showing the Date of Joining in the service availing Ex-Servicemen benefit.
