Sealed Tenders in plain papers are invited by the undersigned for disposal of one Ambassador Car (Diesel) bearing registration No.OR-05G-8686 respectively. The intending tenderers can inspect the vehicle in the office premises of the Odisha Public Service Commission, Cuttack from 11.00 A.M. to 4.00 P.M. on any working day. The competitors shall be required to pay earnest money deposit amounting to Rs.1000/- (Rupees one thousand) only in shape of Bank Draft payable at S.B.I., Cuttack in favour of Special Secretary, O.P.S.C., Cuttack, which will be refunded to the tenderers excepting the tenderers whose tender is accepted.


2. The sealed tenders should reach the undersigned by 3.00 P.M. of 30.07.2014 and the same shall be opened by the undersigned or his authorized officer at 4.00 P.M. on the same day in presence of tenderers or their authorized representatives. The tenderers can submit their sealed tenders either in person in the office of the Special Secretary, O.P.S.C. or by Regd. Post in the same address. Tenders received after 3.00 P.M. of 30.07.2014 shall not be considered.

3. The highest tenderer whose tender will be accepted shall deposit 25% of the offered amount immediately after the sale is confirmed in his favour and the rest amount (after adjusting the E.M.D.) will be deposited within seven days from the date of acceptance of the tender. The successful tenderer shall remove the vehicle from the office of the undersigned alongwith necessary documents of transfer of the concerned vehicle within seven days from the date of deposit of the full amount of the tender. In case he fails to deposit the total amount as per the tender within stipulated time, his deposit including the E.M.D. shall be forfeited.

4. On failure to remove the vehicle within the aforesaid time, ground rent @ 1% of the tender amount shall be charged for each day or part thereof till removal of the vehicle. If the ground rent charged exceeds sale price deposited, the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.


5. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.


